### Rights of the Data Subject

Within the scope of the Article 11 of Law no. 6698 on the Protection of Personal Data, each person has the right to request to the data controller about him/her to

- learn whether personal data are processed or not,
- demand for information as to if personal data have been processed,
- learn the purpose of the processing of personal data and whether these personal data are used in compliance with the purpose,
- know the third parties to whom his personal data are transferred in country or abroad,
- request the rectification of the incomplete or inaccurate data, if any, and request the erasure or destruction of personal data under the conditions in accordance with the law no. 6698 on the Protection of Personal Data,
- request reporting of the operations carried out to third parties to whom personal data have been transferred,
- object to the occurrence of a result against the person himself/herself by analyzing the data processed solely through automated systems,
- claim compensation for the damage arising from the unlawful processing of personal data.

## The Method and Legal Basis of Collection of Personal Data

Within the scope of Distance Education Process, Middle East Technical University Registrar's Office collects verbal, written or online personal data using the following methods in accordance with the law no. 6698 on the Protection of Personal Data, articles 5 and 6 on conditions for processing personal data and conditions for processing of special categories of personal data:
